USCIS provides this list of groups that provide labor consultation and peer letters, but note that it may or may not be up to date. In all instances, whether navigating through USCIS or this list below, be sure to <u>double-check with the specific union or peer</u> <u>organization for the updated procedures and fees before submitting a request for a</u> <u>consultation.</u>

For concert and solo singers, solo instrumentalists (only in the event that less than 50% of a group comprises instrumentalists), dancers, choreographers, stage and assistant stage managers, stage and assistant stage directors, narrators in concert, recital, oratorio, opera and dance. Additionally, other live performers (including songwriters, Disc Jockeys, figure skaters, circus performers, mimes and puppeteers) not covered by other unions such as Actors' Equity or AGVA; live performers in new media formats and actors in non-Equity productions.
